## ALWARRA CORP.

The undersigned, acting as an incorporator of a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

# ARTICLE I

The name of the corporation shall be Alwarra Corp.

### ARTICLE II
