My client received a 2<sup>nd</sup> NOTICE 2000 PROFIT CORPORATION ANNUAL REPORT Packet and brought it to my attention on 8/28/00. We hereby submit payment for the original amount with a request for abatement of the penalty with the following explanation.

The Paw Spa was incorporated by Sheri Ziebel and began operations in 1999. The books and records were maintained by an outside bookkeeper and accountant. All accounting information and records were handed to the accountant early in the year 2000. The accountant informed Ms. Ziebel in March that a corporate extension was filed. She hasn't spoken to him since, other than through occasional phone messages, even though she made countless attempts. Frustrated, she contacted me on 8/24/00 concerned about the 9/15/00 deadline for filing the corporate returns. She again contacted me on 8/28/00 regarding your 2nd notice. Without possession of the physical records, I advised her to keep trying to contact the prior accountant, that I would do the same. To date his only response has been a phone message which was very vague. The corporation intends to have me take over.

To summarize, the Paw Spa is a new corporation; the shareholder, Ms. Ziebel is not familiar with all filing requirements; a professional was hired and entrusted with those responsibilities; and, the first report, if in fact received was forwarded to the accountant who evidently never filed the report.

Please accept this explanation for abatement of the penalty. The 2000 UNIFORM BUSINESS REPORT and payment for \$150.00 are attached. Thank you for your consideration.
