ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ACP SOUTH FLORIDA CORP.

In accordance with Section 607.1003 and 607.1006 of the Florida Statutes, the Articles of Incorporation of ACP SOUTH FLORIDA CORP., a Florida corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is ACP SOUTH FLORIDA CORP.

SECOND: Article IX, Section (1) of the Articles of Incorporation is amended in its entirety to read as follows:

incur any indebtedness other than that permitted under the Loan "(1) Agreement and normal trade accounts payable incurred in the ordinary course of business; or permit or cause ACP South Florida LLC ("ACP Managing Member") to incur, assume or guaranty any indebtedness other than; (i) a mezzanine loan in the principal amount of \$30,000,000 ("Mezzanine Loan") from Highwoods/Florida Holdings L.P. ("Highwoods"), which Mezzanine Loan may be assigned to City National Bank of Florida ("Lender") pursuant to an Assignment from Highwoods to Lender to be dated on or about June 20, 2000 and evidenced by an Amended and Restated Mezzanine Note in favor of Lender in an original principal amount not to exceed \$28,000,000 ("Amended and Restated Note"); and (ii) a pledge of ACP Managing Member's membership interest in Borrower as collateral for such Mezzanine Loan ("Pledge"), each as may amended, modified or extended from time to time;"

THIRD: The foregoing amendment was adopted effective June 19, 2000 by written consent of the shareholders and directors of the Corporation, in accordance with Sections 607.0821 and 607.0704 of the Florida Statutes, constituting a sufficient number of votes for the amendment to be approved.
