OF

ARTICLE I - NAME

The name of this corporation is Casa Rosso Productions, Inc.

This corporation shall exist perpetually, beginning in accordance with law.


ARTICLE VII – BY LAWS



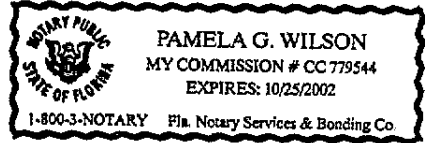


