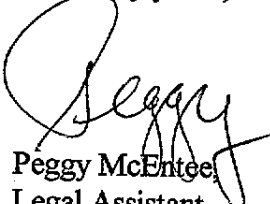

ARTICLE IX - AMENDMENT

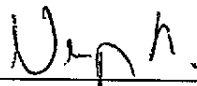

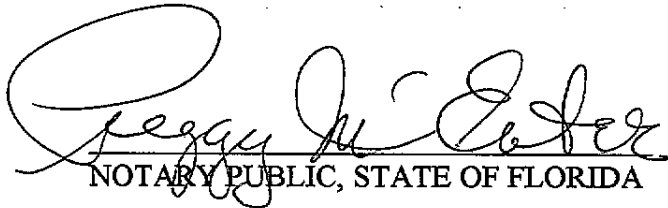

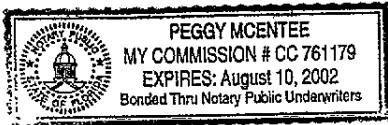
