


ARTICLE IX - INDEMNIFICATION

ARTICLE X - BEGINNING OF CORPORATE EXISTENCE

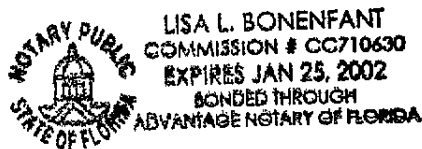




