# ARTICLES OF INCORPORATION FOR KATHY'S HAIR DESIGN, INC.

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

# ARTICLE I: NAME

The name of the corporation is KATHY'S HAIR DESIGN, INC.
