

# CORPORATE PURPOSE

PURPOSES: To engage in the practice of surveying and mapping and the varied processes of determining, documenting and displaying the facts of size, shape, topography, tidal datum planes, legal or geodetic location or relation, and orientation of natural or artificial features on land or in the air, space or water, improved or unimproved real property, including acreage and condominiums, and appurtenances thereto through direct measurement and analysis or from measurement through remote sensing procedures and analysis and the doing of any other business and contracting work incidental to or connected with such work.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate objectives expressed above.
