ARTICLES OF INCORPORATION

OF

O'ROURKE ACCOUNTING SERVICES, P.A.



The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ITEM 1 -NAME OF BUSINESS

1.01 The name of the corporation shall be O'Rourke Accounting Services, P.A.

ITEM 2 - NATURE OF BUSINESS

2.01 SPECIFIC NATURE.—The specific nature of the business to be transacted by this corporation is to engage in every phase and aspect of the business of an accounting firm rendering the same professional services to the public that an accounting firm duly licensed under the laws of the State of Florida is authorized to render.

TTEM 3 – STOCK

3.01 NUMBER.—The maximum number of shares that this corporation shall have authority to issue and to have outstanding at any one time is 1,000 shares. All such shares shall be of a single class, designated as common.

ITEM 4 -CAPITAL

4.01 AMOUNT.—Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of factional shares) at the price at which it is offered to others.

ITEM 5 - CORPORATE EXISTENCE

5.01 DURATION.—This corporation shall exist perpetually unless dissolved by law.

ITEM 6 - ADDRESS OF CORPORATION

6.01 INITIAL REGISTERED OFFICE AND AGENT.—The street address of the initial registered office of this corporation is 2107 Palm Boulevard, Melbourne, Florida, 32901, and the name of the initial registered agent of this corporation at that address is CHRISTINE O'ROURKE.

ITEM 7 - NUMBER OF DIRECTORS
