# ARTICLES OF INCORPORATION OF A PARALEGAL, INC.

# ON SECONDARY OF THE ON STATE O

## ARTICLE I. NAME

The name of this corporation shall be A Paralegal, Inc..

# ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Department of State, Division of Corporations. This corporation's duration shall be perpetual.

# ARTICLE III. PURPOSE

This corporation is being organized for the purpose of engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States Of America.

# ARTICLE IV. CAPITAL STOCK

This corporation shall have the authority to issue 100 shares of common capital stock. The par value of each share shall be determined by the Board of Directors at the time of issuance of each share.

# ARTICLE V. PREEMPTIVE RIGHTS
