The name of the corporation is Letty's Nails, Inc.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any and all lawful business for which the corporation may be incorporated under the Florida Corporation Act.

ARTICLE FOUR


ARTICLE ELEVEN

RESOLUTION TO BE TREATED AS AN S CORPORATION


