


To whom it may concern:

My father, who died on 31 December, 2001, had a Florida business, which has passed to my mother and myself. As I am often out of the country, and my mother is 84 and not really capable of looking after things, we had filed last year's forms to include a registered agent, who would handle any necessary filings or correspondence.


When I checked with the agent just recently to make sure the UBR had been filed for this year, he informed me he did not do it because he did not receive the forms. Nor have I, although my mail send to us should have gone to the registered mailing address, which is also that of the agent. If it had gone to the business address, it would have been forwarded to me here in the UK.

It was my understanding that the UBR would go to the registered agent. I had him check twice, but as I've said, he is certain he did not receive the forms. As it is the first year he has had to do this, it did not occur to him earlier that anything was amiss, as it did not occur to me, because I was expecting the forms to go to him. Since neither of us got them, and the business address did not change, I do not know where they could have been sent.

I have spoken to a member of your staff by telephone and explained the problem. She advised me to download the forms from the internet, send this letter of explanation and the \$150, and that would suffice. I sincerely hope this is so.

I am also taking this opportunity to change the business address to my mother's current address, which will hopefully alleviate any such problems in the future.
