The undersigned, acting as the incorporator of Zorn Acquisition, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation is:

**ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE III. PURPOSE**

#### **ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT**

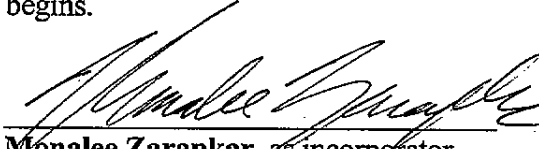

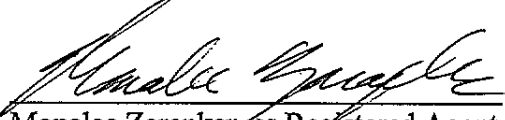
