ARTICLE I. NAME

The name of this corporation is D'KEEPA PRODUCTIONS, INC.

ARTICLE II. PURPOSE

- g. To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
