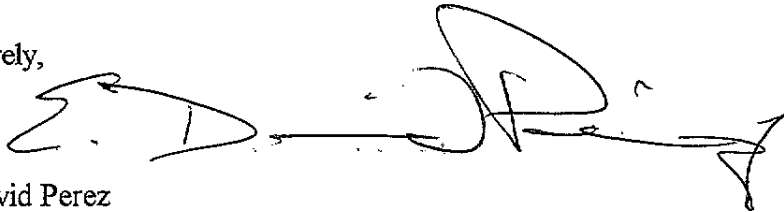

Pursuant to the provisions of section 607.0124, Florida Statutes, this Florida profit corporation declares as follows:

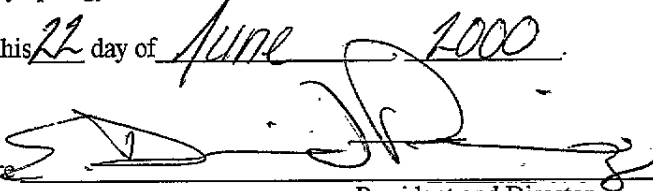

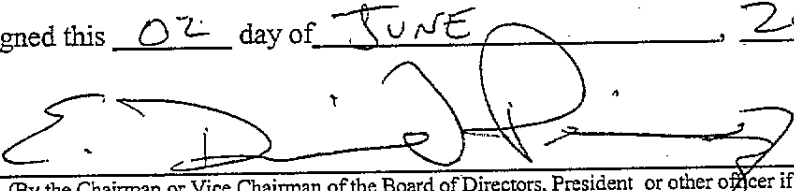
