**ARTICLES OF INCORPORATION

ARTICLE SIX

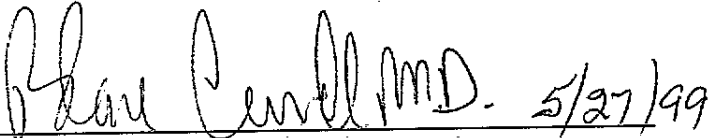
The purpose of the Corporation is to render medical services and to do such other acts as may be permitted by law for a professional service corporation engaged in such activities.

ARTICLE SEVEN

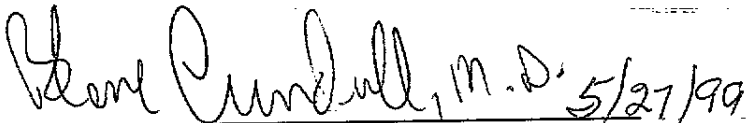
