

- 1. Marvin Reinberg, MD is the President of STRATEGIC FINANCIAL & INVESTMENTS, INC., a Florida corporation, (hereinafter "Corporation").
- 2. That the Corporation was administratively dissolved by the Florida Department of State on September 22, 2000.

- No further ground or grounds exist for the administrative dissolution of the Corporation.
