The Articles of Incorporation of the undersigned corporation were originally filed on June 1, 1999 and assigned document number P99000049191. The Articles of Incorporation were previously amended on October 9, 2002. Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation (these "Articles of Amendment"):

1. The name of the corporation is Premier Personnel, Inc. (the "Corporation").
2. "Article 1. Name" of the Articles of Incorporation of the Corporation is amended and restated in its entirety to read as follows:

"Article 1. Name

The name of the Corporation is:

Premier Home and Commercial Investments, Inc."

3. The Articles of Amendment were duly approved and unanimously adopted by the sole Director of the Corporation on August 10, 2004. The sole Director recommended approval of the Articles of Amendment to the sole Shareholder.
4. The Articles of Amendment were voted upon and duly approved, adopted, and ratified by the sole Shareholder of the Corporation on August 10, 2004.
5. The number of votes cast for approval of the Articles of Amendment by the Shareholders was sufficient for approval.
