Incorporation hereby forms a corporation under the laws of the
State of Florida.

ARTICLE I

The name of the corporation is: N.G.S., INC., a new Florida Corporation. The mailing and business address is 985 N. Collier Blvd., Marco Island, FL 34145.

ARTICLE II

The general nature of the business to be transacted is all lawful business, including the authority:
