ARTICLES OF INCORPORATION

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

I. NAME AND PRINCIPAL OFFICE: The name of this corporation shall be WTM, INCORPORATED. It's principal office is located at 701 West Garden Street, Pensacola, Florida, 32501.

II. DURATION: The period of it's duration is perpetual.

III. CAPITAL STOCK: The corporation is authorized to issue 100,000 shares, all of one class, at \$1.00 par value.

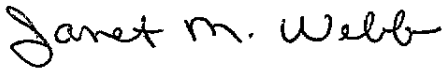

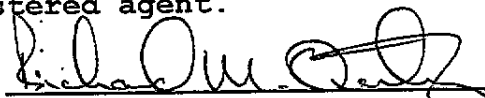
