# ARTICLES OF INCORPORATION

## <u>ARTICLE 1 - NAME</u>

The name of the Corporation is SPOTTERS' BIRD WATCHER SHOPPE, INC., (hereinafter, "Corporation").

# ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.
