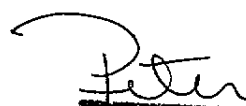

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Law Views Consulting, Inc. Its principal office and mailing address is 14892 S.W. 38th Court, Miramar, Florida 33027.

ARTICLE II - DURATION

The effective date of this Corporation shall be May 25, 1999, and it shall exist perpetually thereafter unless sooner dissolved according to law.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any business activities permitted under the laws of the United States and the State of Florida, in accordance with Chapter 607, Florida Statutes, and any successor statute or law.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.10 per share.

ARTICLE V - INITIAL

The number of director(s) may be increased or decreased from time to time by vote of the Board of Directors, but in no case shall the number of directors be less than one nor more than three. 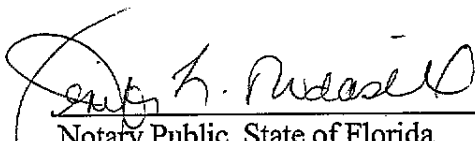

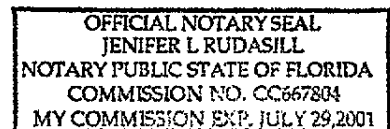
