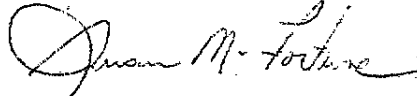

The undersigned corporation, for the purpose of amending its Articles of Incorporation and pursuant to the provisions of §607.187 of the Florida General Corporation Act, hereby executes the following Articles of Amendment:

I. NAME

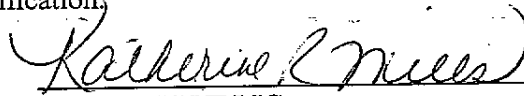
