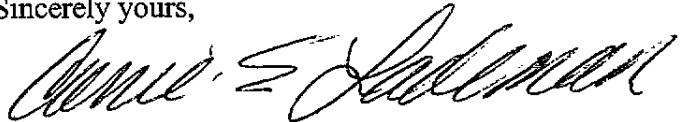

I. NAME

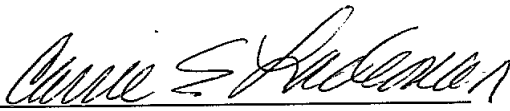

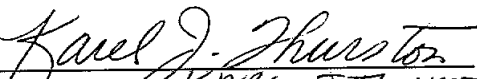
XI. AMENDMENTS

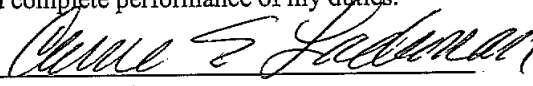
