The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be C. Mark's Towing, Inc. The principal place of business of this corporation shall be 2339 Bruner Lane, Fort Myers, FL 33912.

ARTICLE II. NATURE OF BUSINESS


