***ARTICLE I - NAME***

The name of this corporation shall be **A SECOND CHANCE CONCEPTS IN LIFE & HEALTH, INC.**

***ARTICLE II - DURATION***

The term of existence of the corporation shall be perpetual.

***ARTICLE III - PURPOSE***

The corporation is organized for the purpose of conducting any and all lawful business.

***ARTICLE IV - CAPITAL STOCK***

The corporation is authorized to issue 100 shares of common stock, each share with a par value of \$1.00. There shall be one class of stock. Stock shall not be issued in series.

***ARTICLE V - BOARD OF DIRECTORS***

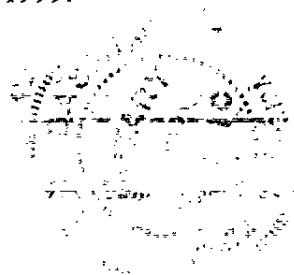

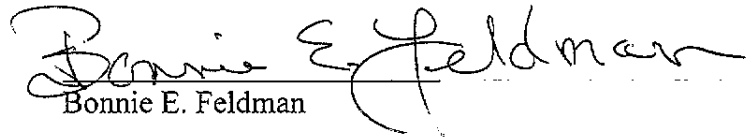

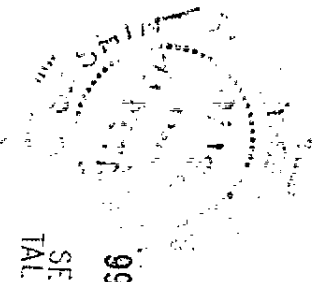
