BY THESE ARTICLES OF INCORPORATION the Incorporators form a Corporation for profit under Florida Law, Florida Statute §607.

ARTICLE I

The name and address of the Corporation are:

ARTICLE II

This Corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is the date on which these Articles of Incorporation are filed with the Secretary of the State of Florida.

ARTICLE III

The purpose or purposes for which the Corporation is organized are to provide asphalt resurfacing, commercial and residential, and to enter any further activity or business permitted under the laws of the United States and of this State.
