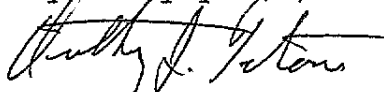

The undersigned incorporator of these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I. - NAME**

The name of the Corporation shall be:

**ARTICLE II. - NATURE OF THE BUSINESS**

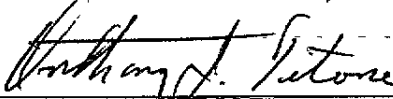

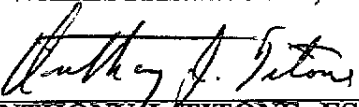

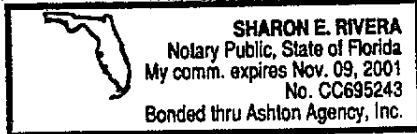
