ARTICLES OF INCORPORATION

OF

CRAIG E. JORDAN, P.A.

The undersigned natural person, competent and licensed to practice law in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida General Corporation Act, and Section 621, Florida Professional Service Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation is CRAIG E. JORDAN, P.A.

ARTICLE II

EXISTENCE AND DURATION

The period of duration of this corporation is perpetual.

ARTICLE III

PURPOSES AND POWERS

The general nature and purposes of business to be transacted, promoted and carried on by the corporations are as follows:

- a. To engage in every aspect in the practice of law, and all its fields of specializations, as are engaged in by attorneys/members of the Florida Bar.
- b. To engage and render the professional services involved only through its officers, agents and employees who shall be attorneys/members of the Florida Bar in good standing and duly licensed or otherwise legally authorized within the State of Florida to the same professional service as this corporation.
- c. To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments permitted by law.
- d. To engage in no other business other than the rendition of the professional service specified herein.
- e. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

ARTICLE IV
CAPITALIZATION

The aggregate number of shares of common stock which this corporation shall have authority to issue is ONE THOUSAND 1,000 shares at par value of ONE DOLLAR (\$1.00) per share. Each holder of common stock shall be entitled to one vote for each share of common stock held.

Shares of the corporation's stock and certificates shall be issued only to attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

There shall be no cumulative voting by shareholders.

The shareholders shall have preemptive rights to acquire any shares of the corporation.

ARTICLE V
INITIAL OFFICE AND AGENT

The address of this corporation's initial registered office is 1040 N.E. 13TH AVENUE, FT. LAUDERDALE, FLORIDA 33304, and the name of its initial registered agent is CRAIG E. JORDAN.

ARTICLE VI
PRINCIPLE OFFICE

The address of the principal office of the corporation 7765 SW 87TH AVENUE, SUITE 201, MIAMI, FLORIDA 33173. The corporation may maintain offices, agencies, and places of business in any other state in the United States and in foreign countries without restriction as to place, as the Board of Directors may from time to time determine or the business of the corporation may require.

ARTICLE VII
INITIAL BOARD OF DIRECTORS

The number of directors constituting the initial board of directors of this corporation is 1. The number of Directors may be increased or decreased from time to time by a resolution of the majority of the Stockholders but shall never be less than one. **ARTICLE VIII
INDEMNIFICATION**

As the Board of Directors may from time to time provide in the By-Laws or by resolution, the corporation may indemnify its officers, directors, agents and other persons to the extent permitted by the laws of the State of Florida.

**ARTICLE IX
SEVERANCE AND TERMINATION OF EMPLOYMENT**

If any officer, director, stockholder, agent or employee of this corporation becomes legally disqualified to render the professional services for which the corporation is organized, or accepts employment that places restrictions or limitations on his continued rendering of such professional services, he shall forthwith sever all employment with the corporation, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized by the corporation on account of professional services. The corporation shall forthwith, upon such disqualification of any shareholder, purchase such shareholder's shares and pay him all amounts owing and lawfully due to him by the corporation, except that such shares shall not be entitled to dividends.

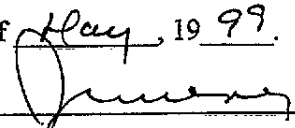
