The undersigned, Casey Rodgers, subscriber and incorporator to these Articles of incorporation, as a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this Corporation is: N.W. Florida Automotive, Inc.

ARTICLE II - PRINCIPAL OFFICE
