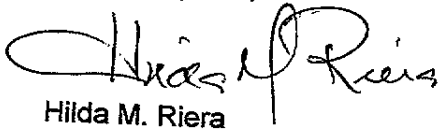

**ARTICLE I**

**NAME AND ADDRESS**

The name of the corporation is Proxim Nivell Corporation. The address of the corporation shall be 2615 Southwest 25<sup>th</sup> Street, Miami Florida 33133

**ARTICLE II**

**DURATION**

This corporation shall have a perpetual existence commencing upon filing of the Articles of Incorporation with the Secretary of State.

**ARTICLE III**

**PURPOSE**

The corporation shall be authorized to engage in and transact any and all lawful business within and without the State of Florida or United States for which corporations may be incorporated under Chapter 607, Florida Statutes, as amended and supplemented.

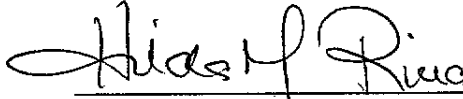

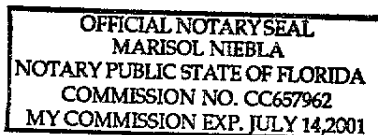
