ARTICLES OF INCORPORATION
OF

REAL OPTIONS, INC.

ARTICLE I - NAME

The name of the corporation is REAL OPTIONS, INC.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

ARTICLE IV - CAPITAL STOCK




