## ARTICLES OF INCORPORATION

# PRECISE APPRAISAL SERVICE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

## <u>ARTICLE - NAME</u>

The name of the Corporation is **PRECISE APPRAISAL SERVICE**, **INC.** Its business location shall be 275 E. Central Parkway, Unit 1518, Altamonte Springs, Florida 32701.

## **ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any or all lawful business or any other activity permitted under the law of the State of Florida and the United States of America.
