ARTICLES OF INCORPORATION

OF

THE CUTAWAY HAIR AND SKIN CENTER, INC.

The undersigned natural person of the age of twenty-one (21) years or more, ALCO PHIS. 53 acting as incorporator of a corporation under the Florida Business Corporation Act. Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation.

ARTICLE 1 - NAME
