ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

EFFECTIVE DATE

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on May 25, 1999.





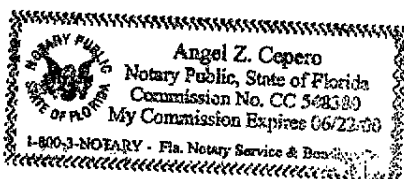
