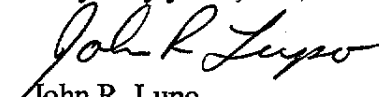

**Section I. Name**

The name of this Corporation is Greenbelt Landscape & Garden Center, Inc.

**Section II. Duration**

The Corporation shall have perpetual existence.

**Section III. Purpose**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and the State of Florida.

**Section IV. Capital Stock**

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$ .01.

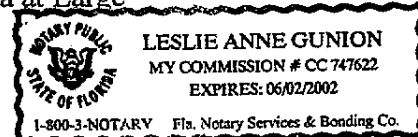
