## ARTICLES OF INCORPORATION OF THE J EVAN COMPANY

TASECTION AN 8.37

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following articles of incorporation:

### ARTICLE I

The name of the Corporation is The J Evan Company.

## ARTICLE II DURATION

The term of existence of the Corporation is perpetual.

## ARTICLE III NATURE OF BUSINESS

The nature of the business to be conducted by the Corporation is:

- 1. To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act;
- 2. To engage in the purchase, sale, development, and construction of real property; and
- 3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
