**ARTICLES OF INCORPORATION**

Article I. The name of the corporation shall be **Tradelinks USA, Inc.**

Article II. The mailing address of the corporation is 8445 International Drive, Suite 154, Orlando, FL 32819

Article III. The corporation shall have the authority to issue the following stock:

1. Voting: 10,000 shares of voting common stock having a par value of \$0.01 per share.
2. Non-Voting: 10,000 shares of non-voting common stock having a par value of \$0.01 per share.

Article VII. The initial Board of Directors shall consist of the following:






