ARTICLES OF INCORPORATION
OF
FIRENZE ENTERPRISES GROUP, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be Firenze Enterprises Group, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be The Bean 2240 Periwinkle Way Sanibel Isl. FLA. 33957, and the mailing address shall be the same.

ARTICLE III CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is 100, consisting of one class only designated as "common stock," with par value of \$1.00 per share.

ARTICLE VII PURPOSE


