ARTICLES OF INCORPORATION
OF
TRANS-NATION CORPORATION

The undersigned, acting as incorporator of this corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be TRANS-NATION CORPORATION.

ARTICLE II - TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE III - GENERAL PURPOSE

The general purpose for which this corporation is organized shall be:

1. To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with products, goods wares, merchandise, real and personal property and services of every kind, class and description.
2. To create an cleaning and maintenance company.
3. It is intended that this corporation is organized for an may conduct and transact any or all lawful business authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be from time to time amended. Provided however, and notwithstanding the generality of the foregoing, this corporation is not to conduct a banking, safety-deposit, trust, insurance, surety, express, building and loan association, mutual fire insurance, association, cooperative association, fraternal benefit society, state fair or exposition business.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is Ten Thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE V - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The initial street address of the registered offices of this corporation and the corporate office in the State will be 45 Drennen Road, Orlando, Florida 32806. The Board of Directors may from time to time move the registered office to any other address in Florida. The name of the initial registered agent of this corporation at that address is Chere R. ARTICLE VI - INITIAL BOARD OF DIRECTORS

The initial number of directors of this corporation shall be three (3). The number of Directors may be increased or diminished from time to time by Bylaws adopted by the Shareholders, in the initial organizational meeting, but shall never be less than one (1).


ARTICLE VIII - AMENDMENT TO ARTICLES


