ARTICLE I - NAME

The name of the corporation is G & C Sales and Service of Melbourne, Inc.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

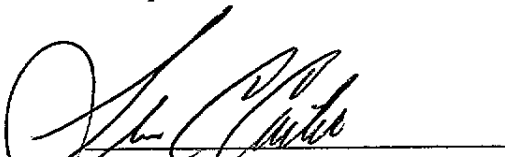

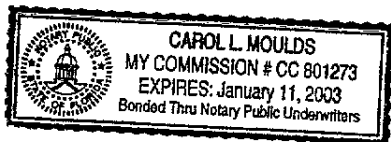

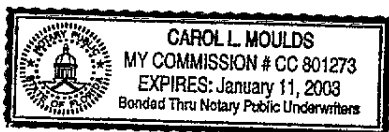
