OF

The undersigned, for purposes of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be Contractor Services, Inc. The principal place of business of this corporation shall be 1541 Grace Avenue, Fort Myers, Florida 33901.

ARTICLE II. NATURE OF BUSINESS


