

ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

ARTICLE I – NAME

The name of this corporation shall be PEPE'S FRUIT & PRODUCE, INC.

ARTICLE II – PURPOSE

This corporation is organized for the purpose of operating a fruit & produce market and all lawful business for which corporations may be incorporated pursuant to the General Corporation Act of the State of Florida.

ARTICLE III – CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 10,000 shares of common stock, each having the par value of \$1.00.

ARTICLE IV – INITIAL CAPITAL

The amount of capital with which this corporation will begin business is \$500.00

ARTICLE V – TERM OF EXISTENCE

This corporation is to have perpetual existence.

ARTICLE VI – ADDRESS

The initial street address of the principal office of this corporation is to be at 3400 Crystal Lake Drive, Orlando, FL 32806. The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.

ARTICLE VII – DIRECTORS

This corporation shall have three (3) directors initially. The number of directors may be increased from time to time by the By-Laws.

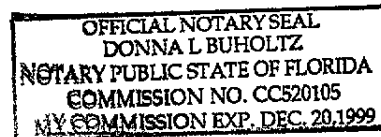
