The undersigned for the purpose of forming a corporation under The Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**Article I: Name**

The name of the Corporation is **SCENOVIA ENTERTAINMENT GROUP, INCORPORATED**,

**Article II: Duration**

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual unless dissolved according to law.

**Article III: Purpose**

The Corporation may engage in any activities or business permitted under the laws of the United States and the State of Florida .

**Article IV: Capital Stock**

The total number of shares of capital stock authorized to be issued by the Corporation will be ten thousand (10,000) shares having no par value per share. Each of the said shares will entitle the holder thereof to one (1) vote at any meeting of the stockholders.

**Article V: Initial Registered Office and Agent**

The Board of Directors may, from time to time, move the principal office to any other address.

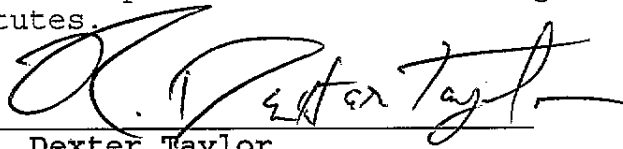
