ARTICLES OF INCORPORATION  
OF  
PREUC REPORTING, INC.

The undersigned incorporator(s) for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be: PREUC REPORTING, INC.

ARTICLE II

This corporation shall have a perpetual existence.

ARTICLE III

This corporation is organized generally for all lawful purposes for which corporations may be incorporated.

ARTICLE IV

The principal place of business of this corporation shall be: 8038 Northwest 15th Manor, Plantation, Florida 33322.

ARTICLE V

The aggregate number of shares which the corporation is authorized to issue is one thousand (1,000) shares. The shares shall be of single class and shall have \$1.00 par value per share. All issued stock shall be held of record by not more than ten (10) persons. Such stock shall be issued and transferrable only to natural persons who are not non-resident aliens.

A majority of the outstanding shares shall constitute a quorum of shareholders' meeting unless the bylaws shall make provisions for some lesser percentage of shares (but not less than 33 1/3%).

ARTICLE VI

The street address of the registered office of the corporation is: 8038 Northwest 15th Manor, Plantation, Florida 33322, and the name of the initial registered agent of the corporation at that address is Cynthia A. Preuc.

The corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

#### ARTICLE XII

to vote thereon, unless all of the Directors and all of the stockholders sign a written statement manifesting their intention that certain amendments to these Articles of Incorporation be made.

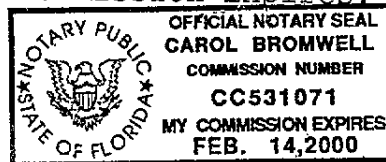

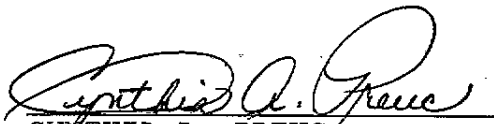
