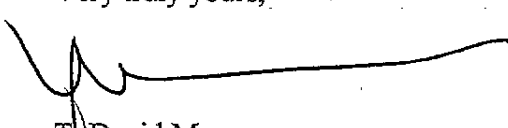

ARTICLES OF INCORPORATION

The undersigned incorporators hereby form a corporation under the Florida Business Corporation Act, and adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be:

DollarMatic, Inc.

ARTICLE II. PRINCIPAL OFFICE; MAILING ADDRESS

The address of the principal office of this corporation shall be 41 North Jefferson Street, Suite 110, Pensacola, Florida 32501, and the mailing address of the corporation shall be the same.

ARTICLE III. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having \$1.00 par value per share.
