ARTICLES OF INCORPORATION

OF

S. MALONE HARVILLE, P.A.

(621 F.S.)

ARTICLE I - NAME:

The name of this Professional Service Corporation is To Lone HARVILLE, P.A., hereinafter referred to as the RESTORTION. S. MALONE HARVILLE, P.A., hereinafter referred to as the "Corporation".

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.
