ARTICLES OF INCORPORATION

OF -1-

ARTICLE I. CORPORATE NAME

The name of this corporation is: -(1)-- WATSON BAYOU MARINA OF BAY COUNTY, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to rent boat slips, provide dry storage for boats, as well as any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any one time is -1,000-- shares of common stock (having par value of \$1.00 per share).

Note: Par Value shares may be issued only for a consideration having a value, in the judgment of the board of directors, at least equivalent to the full par value of the stock to be issued. No par shares may be issued only for such consideration as is determined by the board of directors. All shares issued shall be fully paid and nonassessable.

ARTICLE IV. TERM OF EXISTENCE

The corporation shall have perpetual existence (upon filing of these articles) on


