The name of the corporation is: Linet Real Estate Properties, Inc.

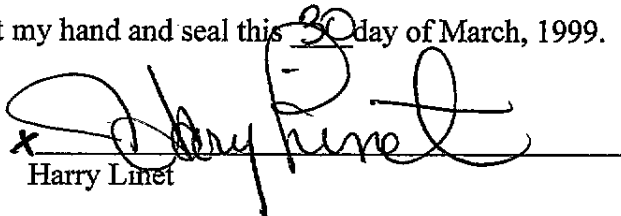

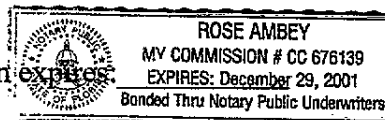
