#### **ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT**

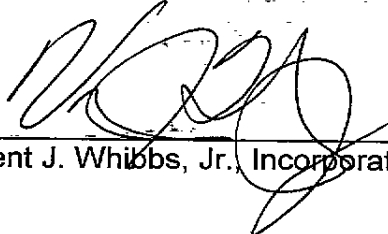
